Terms and Conditions of the Tender

1.0 COMMODITY: Concast Mild Steel Billets; IS 2830:2012 manufactured by Neelachal Ispat Nigam Limited (NINL), DUBURI, JAJPUR, ODISHA.

2.0 DIMENSIONS, SIZE, SPECIFICATIONS & QUANTITIES OFFERED:

Dimension: 150mm x 150mm / Tolerance: +/- 5 mm. Size: 09- 12 meter length / Tolerance: +/- 0.20 meter. The details of the Grades and quantities offered for sale of the Concast Mild Steel Billets are as given in <u>Annexure-A.</u>

3.0 DELIVERY: EX-PLANT, NINL, DUBURI, JAJPUR, ODISHA.

4.0 DESPATCH:

Despatch of CC MS billets shall be done through Rake (1 Rake = approx 2,750 MT) or by Road.

Railway freight in case of Rail movement to be paid in advance to NINL for placing indent with Railways.

5.0 <u>EMD:</u>

5.1 A fixed EMD amount as mentioned in <u>Annexure-C</u> against each Lot is to be submitted for the quoted Lots along with the bid in the form of DD drawn in favor of MMTC Limited payable at Bhubaneswar or through RTGS as per the bank details given below, under intimation to R.O. Bhubaneswar. IFSC code of the bank branch on whom the DD is drawn or the RTGS payment details should also be mentioned under intimation to R.O. Bhubaneswar. No interest shall be payable on the EMD amount.

- **5.2** EMD submitted shall be retained by MMTC in case of successful bidder and the same would be converted into security deposit (SD). The EMD shall be released on successful completion of the tender. In case of unsuccessful bidders the EMD will be refunded within 10 working days of finalization of the orders.
- **5.3** In case the bidder withdraws before the validity of the contract or does not execute the contract as per the terms and conditions of the tender, the EMD/SD will be forfeited.
- **5.4** EMD will not be accepted in the form of Cheques and the bids submitted with Cheques towards EMD will be rejected.
- **5.5** Tenders not accompanied by requisite EMD shall be treated as invalid and hence will be rejected.

6.0 **SUBMISSION OF BIDS**:

6.1 Bids shall be submitted in sealed covers in two parts as mentioned below.

PART A: Technical Bid (Annexure-B)

Technical Bid comprising of:

PART B: Price Bid

Lot wise prices are to be quoted in the price bid as per the format given at **Annexure C**. Bidder has to bid for minimum one complete Lot. Part quoting for the Lots will not be permitted. The Price bid should be put in an envelope super scribing "PRICE BID FOR TENDER NO.: <u>MMTC/STEEL/BILLETS/TENDER/2014-15/02</u> DATED: 23.12.2014".

Both the above envelopes, one containing the **Technical Bid** and the other containing the **Price Bid** should be put in another envelope super scribing "TENDER NO. <u>MMTC/STEEL/BILLETS/TENDER/2014-15/02</u> DATED: 23.12.2014 FOR CONCAST MILD STEEL BILLETS".

- 6.2 Sealed bids should be dropped in the tender box kept at MMTC Ltd., Bhubaneswar or the same can also be sent through Speed Post/ Courier to the R.O. Bhubaneswar at the following address:

- **6.3** Bidders shall quote the rates in figures as well as in words. Corrections if any should be initialed. In case of any discrepancy in words and figures, the rate quoted in words will be treated as final.
- **6.4** In case of discrepancy in the value with reference to the unit rate & the quantity vis-à-vis the total amount column, the unit rate quoted will be taken as final.
- **6.5** The tender documents must be duly signed on all the pages as a token of acceptance of all the terms and conditions.
- **6.6** Bids received through fax/e-mail or bids received after the due date or time will be rejected.
- 7.0 <u>ISSUE OF LETTER OF ACCEPTANCE</u>: MMTC shall issue Letter of Acceptance (LOA) to the successful bidder based on the final rates quoted by the successful bidder and upon acceptance of the same by MMTC.

8.0 **PAYMENT AND DELIVERY TERMS**: The successful bidder should pay the full amount of the material in advance on ex-plant NINL basis by RTGS/DD/Banker's Cheque drawn in favour of MMTC Limited, Bhubaneswar, <u>within 10 days</u> (including Holidays) from the date of issue of LOA. Upon receipt of payment, Delivery Order will be issued. The material would have to be lifted within the period as specified in the Delivery Order or as may be decided by MMTC. - Loading of the material into the Railway wagons will be done by NINL. Payment to be deposited for lot size of 2,750 MT, but in case of delivery by Rake, final quantity will be as per rake placed by Railways.
- **Cutting of Billets** into a smaller length will not be allowed in the premises of NINL plant, Duburi before dispatch of material.
- Invoicing will be done on actual weight of the material. However, Rail-freight will be charged at actuals charged by Railways (RR).
- **Quantity certified as per In-motion Rail weighbridge of NINL** shall be firm and binding to both seller and buyer for making payment and dispatch documents.
- Wagon Unitization Cost will be borne by purchaser at actual which will be approximately Rs. 25/- Per MT.
- Unit of Measurement for invoicing would be in Metric Ton.
- The analysis report on the quality of CC MS Billets furnished by NINL is final and binding on the BUYER.
