## Terms and Conditions :

- The tenderer must be an owner or legally authorized representative of the owner (to be supported by documents) having clear title over the property/hotel and should have interest to offer 02 numbers of AC Rooms (fully furnished i.e. furnished with basic furniture such as cushion bed, cup-boards, tea table with chairs/sofa etc. etc.) on annual rent basis to MMTC for use as MMTC Holiday Home in any floor except Ground Floor and Top Floor of the Hotel.
- 2. The hotel should have all valid documents such as Hotel Registration Certificate, PAN, VAT, Service Tax etc. for entering into a Contract with MMTC for Holiday Home purpose.
- 3. The hotel should be located at Puri alongside the Sea-Beach (from the Swarga Dwar to the Thakur Anukul Chandra Mandir).
- 4. If the Hotel is having more than two Floors excluding Ground Floor, it should have Lift facilities.
- 5. The hotel should have Restaurant & Car Parking facility.
- 6. The tenderer should be agreed to provide all services/facilities to the officials/guests of MMTC, at par with other boarders occupying the AC Rooms of the hotel.
- 7. The tenderer should quote competitive Room Rent only excluding applicable taxes per AC Room per day, both for Sea-facing Rooms and Non-Sea-facing Rooms separately in his/her Price Bid.
- 8. The amount quoted should be inclusive of electricity charges and all other common facilities.
- 9. The tenderer may apply for either Sea-facing Rooms or Non-Sea-facing Rooms or both Sea-facing & Non-Sea-facing Rooms.
- 10. The rate quoted by the tenderer should be valid for minimum 2 years, and can be extended with 10% enhancement from the 3<sup>rd</sup> year onwards for each year with the consent of both the parties.
- 11. The Annual Rent to the hotel shall be released in two equal installments (half-yearly basis) through e-payment only.
- 12. The tenderer should agree to provide Two AC Rooms in good condition accommodating minimum 3 persons in a Room and also having provision for one more personon accommodation with extra bed without any additional charge.
- 13. Before opening of Price Bid, a Committee of MMTC official will visit those hotels qualified in the Technical Bid and verify the facts submitted by the hotels visa-vice prescribed tender parameters and submit their recommendations. The Price Bids of those hotels recommended by the Committee will only be opened for final decision.

- 14. At the time of Committee visit, the tenderer/hotel owner/authorized representative should show the rooms to be allotted for MMTC Holiday Home purpose throughout the year, and give a written communication to the Committee specifying the room numbers.
- 15. Offers received shall remain valid for 90 days from the date of opening of Price Bids.
- 16. The Technical Bid without EMD amount of Rs. 5,000/- (Rupees Five Thousand only) will not be accepted. The EMD of all the tenderers shall be returned/refunded within reasonable time without any interest.
- 17.MMTC reserves the right to reject any or all the offers without assigning any reason thereof.
