TERMS & CONDITIONS

1. The authorized dealer/distributor for supply of Saaransh Digi Board can participate who can supply above items within stipulated time indicated in the supply order and will contribute/provide support, if needed.
2. Sealed tender in two separate envelopes comprising (A) Technical Bid with prescribed EMD & Documents (Annexure-I) (B) Price bid bearing the name of the bidders (Annexure-II) in both bids addressed to Sr. Manager (Admn.) can be dropped at MMTC Limited, IInd Floor, Core-1, Scope Complex, 7, Institutional Area, Lodhi Road, New Delhi – 110003 on or before 1500 Hrs of 10th November, 2014. The tender will be opened on the same day i.e. 10/11/2014 at 1530 hrs.
3. The quotations accompanied with a demand draft of Rs.5,000/- drawn in favour of MMTC Limited payable at New Delhi towards Earnest sMoney Deposit would only be accepted. Any quotation received without the EMD will be not entertained.
4. Quotation received after stipulated date and time will not be accepted.
5. The price quoted will be valid atleast for a period of 3 months and the firm should fully agree to supply the above items on same rates. The firm will maintain the Software/Hardware for a period of one year without any extra charges.
6. The data upgradation of AAJ KA VICHAR and AAJ KA SHABD, will be required on quarterly basis if required, no additional amount will be paid to the firm.
7. Payment will be made only on satisfactory delivery, installation and working of supplied software and hardware in MMTC Limited. The firm will not be paid any delivery and installation charges.

8. All applicable taxes shall be payable by MMTC Limited. The bills raised by the Firm should have all tax registration numbers printed on the bill. Validity of the tax registration shall be the sole responsibility of the Firm.
9. Tenders incomplete in any form are liable to be rejected.
10. MMTC Limited reserves the right to reject any or all the tenders without assigning any reason at any time.
11. If any dispute arises between MMTC Limited and the firm with reference to any terms of the Tender, decision of the competent authority in MMTC Limited will be final and binding upon the firm.
12. After submission of the quotations, a bidder will not be allowed to withdraw his bid for whatsoever reasons. In case of such withdrawal, his earnest money would stand forfeited.
13. In case the successful bidder declines the offer to supply and install the DIGIBOARD at specified locations, for whatsoever reason(s), his earnest money would stand forfeited, and action as deemed fit would be initiated by the competent authority in MMTC Limited.
14. The successful bidder is required to submit the interest free Performance Security Deposit of Rs.10,000/- (Rupees ten thousand only) in the form of DD in favour of MMTC Limited, which will be refunded after one year from the date of successful installation of the software in question.
